## MESSAGE FROM JAMES R. HARDMAN, President Friends of Fircrest

Dear Friends of Fircrest,

2011 ended on a sad note with the passing of longtime Rainier School Chaplain Father James Boyle. One of his last endeavors was a piece he did about **home**. I heard him speak to this topic several times and each time elegantly. RHCs as homes is a concept too easily ignored by RHC opponents. It has been on my mind most recently since the RHCs Futures Task Force so obviously misapprehended the notion in their first public meeting last October 17. What follows is an edited version of Father Boyle's work . The entire text is about 2 pages and will be made available to all on our website.

*Persons* with developmental disabilities are above all else human beings. Society often sees their disability first and the person later, if at all. Because they are persons first, we must **respect** their individuality and their **gift** to the community of persons. We can model our concern and care for them in ways and circumstances which allow them to grow and be free enough to bring their gift as human beings into the greater society..

Respecting the individuality and complexity of persons with developmental disabilities allows for multiple approaches to care. Some can flourish and very well in the greater community setting. We welcome and support such settings. Our experience also gives great credence to giving some persons a more supportive, more structured setting in which to live. What follows are ideas from observations about Rainier School as a **home, a community, and a place of mutuality**.

The word **home** has many meanings according to our experience. **Home** is a place of **belonging**. Home is a place to be **treasured** as an individual. Home is a place of **security** which enables us to **grow**.

**Belonging** is crucial to being human. To be in a place where you have **identity** is to belong. Belonging allows the individual to **nourish and share** his or her gifts, indeed their very beings, with others. Rainier School is a place of belonging. To live at Rainier is to have people **treasure, respect and honor you just as you are**.

**Home** is a place of **security**. Some persons have **complex** disabilities. Sometimes the **combinations** of disabilities adds to complexity. Physical disability may be combined with deep emotional or mental illness. Such complexity requires great **expertise** of care with a very **secure environment**. Persons living at Rainier are often very complex and need a place of security so they can grow and share their gifts without harming others or causing fearful reactions.

Rainier School is a **home** for many persons. Many have lived there many years. The school is a place of **belonging**. It is a place of security where they have grown and shared their lives.

As humans we all need a home, a place of belonging. We also need a **community** around us. To be in a community means to be in a place where we share our lives with many. A community gives us identity not only with family but with our **culture** and greater society. To be in communion means we are free to live the to and fro of care and love. Community often favors the more capable, embracing the more powerful. Persons who are less capable, more involved in their disabilities, sometimes burdened with certain behaviors can be shut out of or shunned by greater society.

For those carrying very complex disabilities Rainier School provides a very **accepting community**. Rainier is a place of greater security where violence is not allowed. An environment where people learn to respect others and be respected. Expertise and security **enable freedom** for each individual to grow, be respected, nourished, and be part of a vibrant community.

Lastly, a place of **mutuality** is where we can freely exchange the gifts of life which exist in all of us. **Each life is precious** . When we share the richness within ourselves we truly live. This sharing of our lives, with all the complexity and uniqueness fulfills us and brings us joy.

Rainier School is a place where lives are shared. **Staff** bring **care** and **compassion** to people. Great and meaningful relations come forth. When persons with disabilities are respected, cared for, and loved, they are free to enter relationship. They often bring to their relationship great unconditional affection and love. They love from a place of weakness and vulnerability so they can love freely and without reservation. To be loved just the way you are can be so disarming and so beautifully human. To be allowed to bring the gift of your very self into such a relationship brings great bonding and deep friendship.

Such relationships of life **need time and consistency**. Both exist at Rainier School. A place of **mutuality of gifts and love** gives true human life to each who share such a relationship.

**Rainier School is a home.. a community.. a place of mutuality in friendship.**

## LEGISLATIVE REPORT

The 2012 Legislative Session began in early January. The Governor has proposed many cuts to the overall Developmental Disabilities budget. Some of these cuts include Changing Eligibility Requirements for DD Services, Blending some of the Home and Community Based Waivers, Eliminating Adult Day Health, Closing Rainier School and general cuts to DD programs.

On the Bill Front: HB 2581 was introduced by Representatives Sherry Appleton, D-23<sup>rd</sup>, Steve Tharinger, D-24<sup>th</sup> and Connie Ladenburg, D-29<sup>th</sup>. This Bill requested the 2 Sections of 2SSB5459 (closing Morgan Center) be reinstated. The Bill was scheduled for a Public Hearing on Friday, January 27, but was withdrawn from the calendar of the Early Learning & Human Services Committee, chaired by Rep. Ruth Kagi.

This was done at the request of Sen. Adam Kline, prime sponsor of last session's closure bill. We will keep you posted regarding progress made on this bill & any others impacting the RHCs.

### **You are invited to join ActionDD -your statewide advocacy for Fircrest and other RHCs -**

ActionDD began in 1991 when concerned families, friends and professionals challenged the closing of our state Residential Habilitation Centers (RHCs.) We pooled our resources, hired a lobbyist and went to Olympia.

We soon learned that not only were residents of RHCs in danger of losing needed services, but that others *not* in RHCs were going without services altogether. To make matters worse, advocates were not working together but were instead fighting over who would get precious resources and who would not. Unity became one of our goals and remains an important part of our advocacy.

We have concluded that a continuum of services must be available -- exclude no one. To that end we advocate for keeping and improving our RHCs, and opening RHC services to people with developmental disabilities who live in our communities.

Today, advocates volunteer their time and money so that our state legislature, the bureaucracy and care providers, can have a better understanding of the needs of people with developmental disabilities and a greater willingness to provide for them. Our lobbyist supports these goals on our behalf, in Olympia.

**New Requirements for Non-Professional/  
Family Guardians**

Effective July 22, 2011 House Bill 1053\* has amended RCW 11.88 and 11.92 and will require additional steps to petition for guardianship or to have your annual reports approved.

**For Existing Guardians**

1. When submitting an annual report (Periodic Personal Care Plan or Guardian's Report & Accounting) a guardian must submit proof of the AOC online training. ([www.courts.wa.gov/layguardiantraining](http://www.courts.wa.gov/layguardiantraining))
2. If you do not have a computer connected to the internet, ask a relative or friend or go to your local library and use their computer.
3. This message is for FOF members who need to utilize the library for the lay guardian training. Prior to going to the library, please contact Kim Rood, Admin. Office of the Courts at 360-705 5314. She has offered her assistance to gain access to the training information.
4. After registration and completing the lay guardian training, please print your information for your file. Especially print the 'Declaration of Completion of Training' form with an **identifying number**. This will be needed when you file your guardianship renewal or file for the first time.

**PROTECTIVE SAFEGUARDS "HELD UP"****Legislature Pulls "Tommy's Bill"**

Last year we lost the Frances Haddon Morgan Center when Senate Bill 5459 was passed. Friends of Fircrest worked long and hard alongside families from other RHCs and our friends in the union, to defeat that bill, but it closed the Morgan Center on December 9th. Eighteen of the residents moved to Fircrest, two went to Lakeland village and one went to Rainier School. The remaining thirty or so residents went to SOLAs and other community placements.

A few who relocated to Fircrest required additional care because of behavior problems related to the move. We don't know how well the community placements went, but one man, Tommy Murray, died from what seemed to be negligence when he drank laundry detergent from a milk carton.

To protect others who move from RHCs, Friends of Fircrest and ActionDD proposed a bill that would add safeguards for people leaving an RHC. The safeguards included; a right to return, counseling from mentoring groups, visits to prospective homes and quality assurance among others. We called our bill, "Tommy's Bill" HB 2581.

On the day that Tommy's Bill would have heard public testimony it was removed from the public hearing calendar. Senator Adam Kline wants the issues in the bill referred to the RHC Task Force created last year by SB 5459. These safeguards may not be considered until the RHC Task force winds up at the end of this year. In the meantime, residents leaving an RHC remain at risk.

**CAMPUS NEWS****Highlights of Dr. Asha Singh's Report to FoF Members, January 8,**

- New Fircrest Assistant Superintendent, Brad Benoit has been hired. Dr. Singh will be out of country in February. He can be reached at 206 361 3014 . FoF welcomes Brad and hopes to see him at our meetings.
- The 18 residents from FHMC are settling in here at Fircrest. Most are doing really well. A few have had adjustment issues.
- We will be hiring permanent staff for AC managers, AC2 & AC3's rather than using temporary employees. This will be better for all and help stabilize staffing.
- Fircrest continues to have some short term stays and crisis respite clients. Cottages 313 & 314 have been reopened but there is not yet staff for the units. Some units have seen increased staffing ratio due to resident support needs.
- Consolidation of maintenance services has gone much smoother than anticipated. The tracking of and paper work has increased but so far no impact on getting things done. The consolidation of business operations is still facing challenges and issues. Replacement staff is not yet in place.
- We are still looking for additional Medical Care Provider– MD or ARNP.
- All admissions to Fircrest go through DSHS Assistant Secretary, Maryanne Lindeblad. Admissions of youth under 21 would be an exception to the policy not allowing under 21 admissions after July 1, 2012. That youth (under 21) who are currently residents, we assume, will not have to move. This will have to be confirmed with the Assistant Secretary. Current census is about 200 clients.
- Currently Fircrest has a positive balance. FHMC clients moves to Fircrest have not hurt us dollar wise.

**GOALS & PROJECTS**

Besides continued support with contacting legislators to keep all RHCs and restoring programs that have been cut (i.e. re-open the infirmary, & pool/activities building), your board has identified *many* projects for this year. Maybe overly ambitious, but important goals never the less. Each goal needs to sustain momentum to reach completion. We ask all members to make a commitment to one or more of the below:

Develop a Parent handbook to guide new and existing families of residents (short and long term) thru the processes of working with and through the various systems and programs and protocols at an RHCs, which can be at times, confusing daunting & frustrating. Input from new families would be wonderfully helpful. Email ccbaley@Q.com

Develop the established Family Council required by CMS (Center for Medicaid Services) for ICFMR & SNF facilities for resolving and getting results for complaints, concerns and grievances as identified by client advocates.

Assist guardians with the newly required training for requirements of responsibilities and rights of guardianship.

Establish a Post High School Personal Development program (perhaps a long term goal) to prevent learned skills from being lost and fill void between school and employment.

Campus Usage and Development: Engage with local professional entities who would partner with us to establish and expand services and facilities for RHC residents and for those in the DD community who are under or un-served.

Continue to enhance and maintain our Therapy and Healing Gardens and fund music & recreation programs for residents.

Update our FoF literature. Get our members to sign up for e-mail delivery of our Newsletter. See pg. 6 .

**RAISE FUNDS.** We need an active fundraising program. *Our donation are down.* Increasing our membership fees this year will help cover the costs of fulfilling our mission. See page 7 for annual dues.

**TREASURERS' 2011 REVIEW**

The year 2011 was not a friendly one to services provided by DSHS funding. The cuts for programs and staff reduced many activities including outings, adult training program hours, closure of the popular cafeteria and coffee shop. Friends of Fircrest supported and actively participated in campus and community activities with financial assistance made possible by the generosity of our members, donors and supporters for the following:

- ◆ Funds to the residents' homes to use as they needed for recreation and socialization activities including live music performances on campus.
- ◆ Gas Barbecue Grill for use at outdoor events on campus.
- ◆ Support for campus wide annual Funfest Parade and Picnic with live music, food booth and games.
- ◆ Support for Fircrest's Senior Program with donations such as HDTV, exercise equipment, music instruments and other amenities as requested.
- ◆ Support for seasonal events: using the "Healing accessible garden for Funfest live music and food booth.
- ◆ Amenities for the Therapy Garden; picnic tables, benches and support walking bars
- ◆ Chapel needs for music and flowers.
- ◆ Funding for printing of volunteer produced informational brochures for interactive participation in many Shoreline events including annual participation with the Shoreline Community Parade and Festival.
- ◆ Shoreline Chamber of Commerce membership to keep Chamber members updated on issues affecting Fircrest.

Friends of Fircrest has kept expenses for the above within the 2011 budget. Reserve Accounts are not able to be used for operating budget needs. This includes contingent funds set aside for Legal, Public Relations. We have one 'Restricted Account' with funds to be used solely for the Jacqueline MacRae Therapy Garden.

Our budget committee is currently preparing the 2012 budget proposal to board and members. Like other non -profits we have seen a reduction in the amount of donations and our operating account is not able to cover our goals at the same level as we have in years past without a major infusion of funds. This will be the year that our fundraising efforts need to be activated. We need everyone to participate for the sake of our loved ones at Fircrest
